Your title package will be split into an eSign and Remote Online Notarization (RON) package. The eSign documents will be combined with the lender package and sent to the consumer to complete. 2 Set the appointment The date, time, and remote online notary webcam appointment details will automatically be shared with the consumer. 3 Ensure eSigning is complete Prior to the webcam appointment, remind the consumer to eSign their non-critical documents. The remaining critical documents will be signed with the notary over webcam. 4 Download signed documents All signed documents will be available to you and your lender. Download these documents from Snapdocs so that the closing can be eRecorded. Simple, right? Let's get started. Upload title documents & set appointment

Schedule signing appointment

Must be at least 2 hours after title documents are uploaded to allow for processing. Please keep in mind the appointment time defaults to the timezone of the property address, NOT the signer's location.

Note: the utilization of Notarize's On-Demand notaries does not guarantee a notary will be available 24/7. It is recommended to schedule a notary between business hours of 9am-9pm in the signer's respective time zone.
